

There are three main payment methods to pay your GST/HST to the CRA.
CRA 에 비즈니스 세금을 납부하는 방법은 크게 3 가지로 나눌 수 있습니다.

1. Remit electronically (**Visa Debit or Debit Mastercard only**)

Please note that payments of \$10,000 or more must be made electronically or through a financial institution.

Payments to the CRA

Pay with a debit card through the CRA's My Payment service

You can make payments directly to the CRA using your bank access card (Visa Debit or Debit Mastercard) through the CRA's secure electronic service called My Payment.

Pay now using My Payment

You **cannot use credit cards** with My Payment.

How to Pay at a Financial Institution in Canada 캐나다의 금융기관을 통한 납부 방법

1. If you filed your GST/HST return via GST/HST NETFILE or GST/HST TELEFILE, you can make your payment at a financial institution using a **remittance voucher**.

GST/HST NETFILE 또는 GST/HST TELEFILE 을 통해 세금 신고를 온라인으로 진행하셨다면

Remittance voucher 를 이용해 금융기관에서 납부하실 수 있습니다.

2. Enter the payment amount in the “**Amount paid**” box on Form **RC158** (Remittance Voucher - Payment on Filing).

RC158, Remittance Voucher - Payment on Filing 의 “**Amount paid**” 박스에 납부 금액을 입력해주세요.

* Remittance vouchers can be ordered online through your **CRA My Business Account**.

* Remittance voucher 는 **CRA My Business Account** 에서 주문하실 수 있습니다.

How to Pay by Mail 우편을 통한 납부 방법

1. If you wish to make payment by mail, you will also need a **remittance voucher**, similar to paying at a financial institution.

우편을 통해 세금을 납부하는 경우에도 금융기관을 통한 납부와 마찬가지로 **Remittance voucher** 가 필요합니다.

2. Enter the payment amount in the “**Amount paid**” box on Form **RC158** (Remittance Voucher - Payment on Filing).

RC158, Remittance Voucher - Payment on Filing 의 “**Amount paid**” 박스에 납부 금액을 입력해주세요.

3. Prepare a cheque for the payment amount. Please make the cheque payable to **Receiver General for Canada**.

체크에 납부 금액과 수신인 (cheque payable)은 **Receiver General for Canada** 로 입력합니다.

4. Address the envelope as follows:

봉투에 적는 수신인과 주소는 아래와 같이 입력해주세요:

5. When paying by mail, please ensure you allow sufficient time for postal delivery so that your payment is received on or before the due date.
